### 1. Roll Call

### 2. [Final Approval on First Appearance] Approve the Resolution Making Findings to Allow Teleconferenced Meetings under California Government Code Section 54953(e) - ACTION

### 4. Community Advisory Committee Report – INFORMATION

Kevin Ortiz, Vice Chair of the Community Advisory Committee (CAC), stated that there was an update to the CAC by-laws that allowed for a Vice Chair election where he was elected Vice Chair. CAC Vice Chair Ortiz reported that the CAC unanimously supported Prop 30 as well as the Prop K allocations that the Board would consider

later in the meeting. Additionally, he noted that the CAC received updates on Vision Zero enforcement, the San Francisco Transportation Plan, and the One Bay Area Grant Cycle 3 nominations, focused on the BART elevator modernization projects.

Chair Mandelman thanked outgoing CAC member Peter Tannen and District 8 representative for his 14 years of service on the CAC and all the knowledge and experience that he brought with him from personal experience and a long career in transportation. He invited Mr. Tannen to say a few words.

Peter Tannen thanked Chair Mandelman and the Board for the recognition. He was happy to have served on the CAC for many years and joined after working for the City for fourteen years so that he could stay current in transportation issues as well as provide input. He said he planned to continue to listen in to Transportation Authority meetings and call in for public comment.

Amelia Walley, Analyst, presented the item per staff memorandum.

Rachael Ortega spoke to her interests and qualifications in serving on the CAC.

During public comment, Peter Tannen spoke in support of Rachael Ortega and related that he was especially impressed with her using many different modes of transportation as well as her background in operations planning and budget and financial analysis.

During public comment, Aleta Dupre said that the BART faregates project was important to her because she used BART and replacement of the old faregates was overdue. She said it was important to consider that BART had not yet sunsetted paper tickets, but that they eventually would. She said that the cost of including paper ticket readers in the faregates should be considered and that not all 86 faregates should include paper ticket readers in order to reduce costs.

During public comment, Roland Lebrun summarized the letter that he submitted as a public comment and that was included in the packet. He expressed concerns about comments made by the interim Caltrain executive director because they conflicted with current legislation that established the terminal at the Salesforce Transit Center, not 4<sup>th</sup> and King. His second point was that and there was a court ruling from 2016 that reaffirmed the location of the terminal at the transit center. His third point was that he believed it would be helpful for the Board to provide guidance to Caltrain to relocate the existing 4<sup>th</sup> and King street station to 5<sup>th</sup> street to facilitate entitlement which should ultimate result in hundreds of millions of dollar of local funding which would result in increased funding for the Pennsylvania Avenue Extension and the Downtown Extension.
