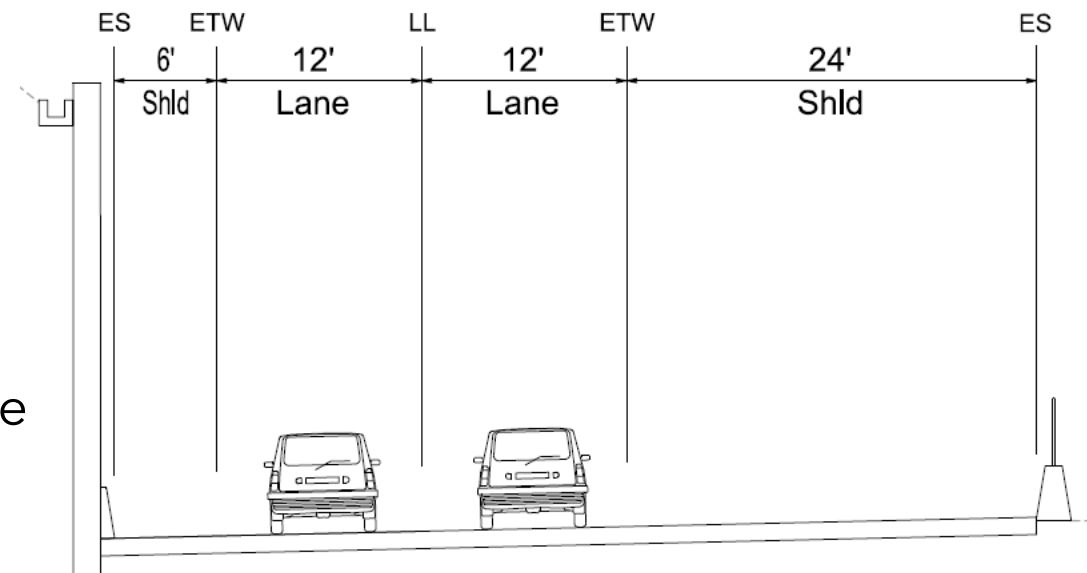
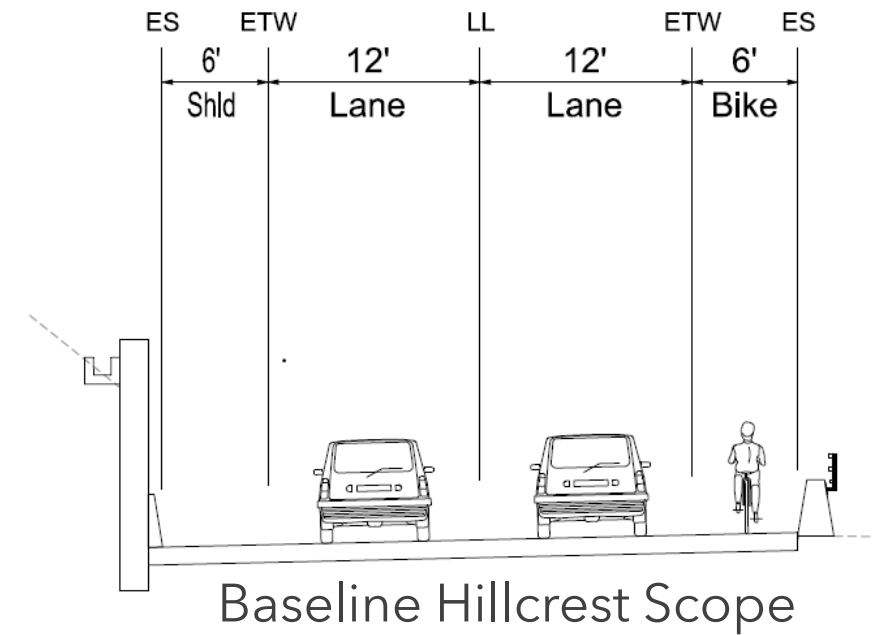

YBI MUP Segment 2 within the Hillcrest Road Project

- The future Yerba Buena Island Multi-Use Path Project (YBI MUP) project will construct a 16' wide separated Class I bike/pedestrian pathway
- The Hillcrest Roadway Improvement Project can be built to accommodate future implementation of Segment 2 of the YBI MUP through the project's upcoming construction contract
 - Includes a wider shoulder area and retaining walls that accommodate the future MUP
 - More cost effective to build now; avoids costly future demolition and reconstruction



Hillcrest Road Improvement Project Funding Plan

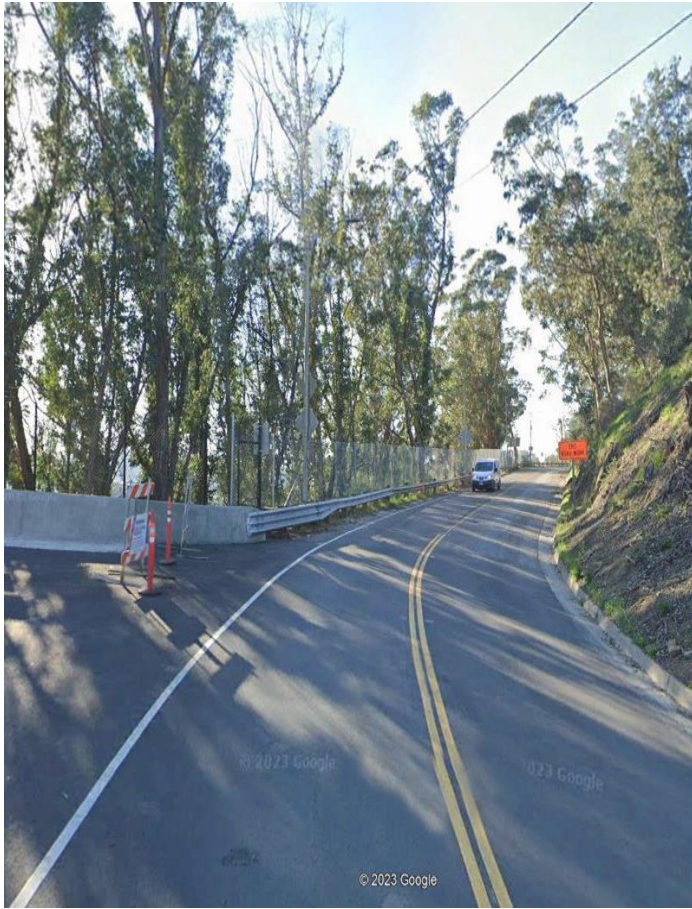

Funding Actions: Program LPP



- Program \$2,601,000 in Senate Bill (SB) 1 Local Partnership Program (LPP) Formulaic funds to the following Transportation Authority projects:
 - **\$2.6M** to Hillcrest Project Construction
 - **\$1k** to YBI Multi-Use Pathway Design

Funding Actions: Fund Exchanges



- Approve Two Fund Exchanges, with Conditions, to Fully Fund the Hillcrest Project, Including Accommodations for a New Class I Multi-Use Pathway:
- Exchange **\$750,000** in County Share One Bay Area Grant 3 (OBAG 3) funds from the Transportation Authority's YBI MUP project with an equivalent amount of Prop K funds from the SFMTA's Light Rail Vehicle (LRV) Procurement Project
- Exchange **\$4,100,000** in Regional OBAG 3 funds from the YBI MUP project for an equivalent amount of Prop K funds allocated to the SFMTA's LRV project.

Funding Actions: Appropriation

- Appropriate, with Conditions, **\$4,850,000** in Prop K (Exchange) funds to for Design and Construction of the Hillcrest Project



Next Steps / Schedule

- **Fund Exchange**
 - December 2023: MTC Commission considers for approval
- **LPP-F Funds**
 - Late November 2023: Submit nomination to California Transportation Commission (CTC)
 - January 25-26, 2024: CTC meeting to program funds
- **Hillcrest Construction Schedule:**
 - February 2024: Advertise construction contract
 - June 2024: Construction begins
 - Estimated Completion: End of 2026/Early 2027
