The San Francisco County Transportation Authority (Transportation Authority) is pleased to announce a call for projects for \$42.286 million in One Bay Area Grant Cycle 2 (OBAG 2) County Program for San Francisco over the next five years (Federal Fiscal Years (FYs) 2017/18 to FY 2021/22).

INTRODUCTION

Through the [OBAG program](#), the Metropolitan Transportation Commission (MTC) directs federal funding to projects and programs that integrate the region's transportation program with California's climate law and Plan Bay Area (the Regional Transportation Plan/Sustainable Communities Strategy). In November 2015, MTC adopted the OBAG 2 framework, which was revised in July 2016 to distribute additional revenues and incorporate housing-related program elements. OBAG 2 maintains largely the same framework and policies as OBAG 1, with some refinements to reflect lessons learned and a new regional focus on core transportation infrastructure and affordable housing.

About 45% of OBAG funds are directed to county Congestion Management Agencies (CMAs), such as the Transportation Authority, enabling them to select their own OBAG program of projects. Provided that the CMAs comply with MTC’s OBAG requirements, they have flexibility to program funds to a wide variety of project types that cater to local priorities (link to MTC’s [OBAG 2 guidelines](#)).

FUNDS AVAILABLE AND ELIGIBLE PROJECTS AND SPONSORS

\$42.286 million is available for programming over the next five fiscal years (2017/18-2021/22) for two categories, as summarized below:

- **Safe Routes to School (SRTS):** MTC has designated a funding set-aside for SRTS based on each county’s total kindergarten through 12th grade enrollment, with a \$1.797 million share for San Francisco. Given very limited funding sources for non-infrastructure programs (e.g. education and outreach), we will give priority to these types of projects for this dedicated SRTS funding. If we do not receive any non-infrastructure applications, this set-aside could be awarded to infrastructure projects.
- **Countywide OBAG 2:** For the remaining \$40.489 million countywide program, the broad range of eligible project types include but are not limited to:
 - Transit expansion;
 - Reliability and access improvements;
 - Smart system management;
 - Transportation demand management (including education/outreach);
 - Safety and streetscape improvements;
 - Street resurfacing; SRTS; and
 - Priority Development Area (PDA) planning and implementation.

Given the restrictions associated with the OBAG 2 fund sources, only public agencies that already have a co-op agreement with Caltrans are eligible applicants. Other applicants must partner with an eligible agency in order to compete for OBAG 2 funds.

SCREENING AND PRIORITIZATION CRITERIA

Our Board-approved [OBAG 2 SF Screening and Prioritization Criteria](#) include all of the required MTC guidelines, supplemented by San Francisco-specific screening and prioritization criteria, including those intended to address the City's growing needs in core capacity and reliability improvements. The [Evaluation Score Rubric](#) lays out the scoring methodology for each of the prioritization criteria.

- The project-specific prioritization criteria retain most of the Board-approved San Francisco-specific criteria that we used for OBAG 1, such as multi-modal benefits, multiple project coordination, and safety. In particular, given the challenge of meeting the federal timely use of funds requirements, we will continue to give strong consideration to project readiness (for more detail on the timely-use-of-funds requirements, please refer to [MTC's Regional Project Delivery Policy Guidance](#), especially the list of major deadlines on the last page).
- MTC requires that at least 70% of San Francisco's OBAG 2 funds to be invested in or providing proximate access to PDAs (net of the SRTS guaranteed minimum). There are also other location-specific prioritization criteria that reward projects in or near other geographic definitions, including: High Impact Project Areas; Communities of Concern; and Air District Community Air Risk Evaluation areas. Given the region's heightened concerns about the lack of affordable housing, we will also reward projects in PDAs near proposed housing developments with 75% or more affordable units. APPLICATION PROCESS

To apply, please submit an electronic version of the OBAG 2 application form and associated attachments **in the original format (e.g. MS Word or Excel)**, as well as one PDF of the entire application, via email to obag@sfcta.org by 4:00 PM on April 26, 2017. Every project must have its own application. If a sponsor submits more than one application, please indicate project priority order in the project applications or other correspondence.

All OBAG 2 applicants must also complete and electronically submit [MTC's Complete Streets Checklist](#) at the time of application submittal. MONITORING AND SUPPORT

As the CMA selecting OBAG 2 priorities for San Francisco, the Transportation Authority is responsible for ensuring that projects are delivered in a timely manner, that they remain consistent with the original purpose and general scope approved by the Board and MTC, and that no federal OBAG funds are lost to San Francisco. As such, sponsor agencies awarded OBAG 2 funds will be required to provide regular updates to Transportation Authority staff on

project status and activities; major milestones; project changes; and any issues that may affect project delivery and costs. We expect these updates in a timely manner but no less frequently than quarterly via the Transportation Authority's [online Grant Portal](#) (please email Eric Reeves at eric.reeves@sfcta.org for access or with any questions). Ongoing communication enables Transportation Authority staff to assist with resolving issues and keep our Commissioners and the public up to date on San Francisco's OBAG 2 program.
