Mike Pickford, Senior Transportation Planner, presented the item per the staff memorandum.

Commissioner Fewer stated that she had been working with District 1 residents around traffic safety along the California and Fulton street corridors. She said District 1 residents delved into discussions for what safer streets would look like through the Central Richmond Traffic Safety project and suggested strengthening bike east-west connectivity and improving safety on Anza Street. Commissioner Fewer said the project would look at the crash history, traffic counts, speed surveys and potential near-term improvements along the Anza Street corridor; 1.5 miles from Arguello Boulevard to 26th Avenue. She noted that a well utilized bike lane on Cabrillo Street could be used as an example and looked forward to engaging in the process and discussion with my District 1 residents and community stakeholders as a way to hear from them directly and gather feedback.
