

MNS Engineers Contract Amendment

- **Construction Management Services - July 2017**
- **Assisted with critical constructability reviews**
 - Construction duration increase - 12-15 months to 24-26 months
- **MNS Engineers DBE Participation:**
 - DBE contract goal 10.2%; MNS targeting 24%
 - DBE subconsultant firms:
 - Transamerican Engineers & Associates, Inc.
 - Inspection Services Inc.
 - KL Bartlett Consulting
- **Will comply/enforce COVID-19 on-site requirements**

Requested Actions Item #15

 - Amendment No. 2 - TIDA to accept fee title directly from the USCG
- **TIDA MOA for Construction Phase - Amendment No. 2**
 - Amends total construction phase cost and funding
