DRAFT MINUTES

San Francisco County Transportation Authority

Tuesday, July 28, 2020

1. Roll Call

Chair Peskin called the meeting to order at 10:02 a.m.

Present at Roll Call: Commissioners Fewer, Mandelman, Mar, Peskin, Preston, Stefani, Walton, and Yee (8)

Absent at Roll Call: Commissioners Haney, Ronen, Safai (entered during Item 3), and Yee (entered during Item 2) (4)

Chair Peskin made a motion to excuse Commissioner Ronen, which was approved without objection.

2. Chair's Report - INFORMATION

Chair Peskin congratulated staff and project funding partners Treasure Island Development Authority, Caltrans, Bay Area Toll Authority, and the United States Coast Guard on the groundbreaking of the Southgate Road Realignment Project which commenced earlier in the month. He added the \$64 million project will provide a safer connection for bicyclists and pedestrians, as well as east bound motorists onto I-80 and the San Francisco-Oakland Bay Bridge.

Chair Peskin conveyed solidarity and support to the MUNI operator who was assaulted by three juvenile passengers, after asking them to wear face coverings for public health and safety; compounding the incident was that it was possibly a hate crime on those of Asian descent in regards to the coronavirus. He reported he had made inquiries to the San Francisco Police Department and District Attorney's office and would ensure a thorough investigation was held, standing with all the drivers and front-line workers during the COVID pandemic and show no tolerance for hate or abuse.

Chair Peskin also announced that he, along with Commissioners Walton and Haney, introduced a Caltrain 1/8-cent sales tax to be placed on the November ballot. He stated he remained hopeful that the San Mateo County representatives will join the Transportation Authority in supporting a comprehensive path forward that will advance the measure of the voter consideration, and if passed, would set up an immediate and long term source of funds for Caltrain. Chair Peskin added now was the time for all partner counties to come together and fund Caltrain to create an equitable, accountable organization.

3. Executive Director's Report - INFORMATION

Tilly Chang, Executive Director, presented the item.

Commissioner Preston inquired how federal funds were allocated to projects beyond the Cares Act, which Director Chang had mentioned in her report. He added that constituents were concerned with the loss of bus lines during this pandemic and were eager for solutions to bring the lines back. Director Chang responded that the Federal Transportation Administration (FTA) provided each transit operator on an annual basis with formula funds to be used on capital projects in a normal year; however, due to the current pandemic, FTA provided permission for operators to use their formula capital monies for operations. Director Chang stated that the Board could invite back San Francisco Municipal Transportation Agency (SFMTA) Director Jeffrey Tumlin to discuss how the agency would be approaching future financial decisions about the use of the federal funds given that this new flexibility exists. [Subsequently, Joel Goldberg, SFMTA, noted that the SFMTA has been evaluating FTA funds previously awarded to capital projects and reprogramming them, when it makes sense to cover COVID-related operating costs. In most cases, Mr. Goldberg said these funds were under contract and couldn't be redirected, but he said SFMTA was closely looking at remaining balances to determine feasibility of moving funds towards operating costs.]

During public comment, Aleta Dupree requested that the Transportation Authority support the Clipper START program and said the program would be helpful for the people who were not traveling as frequently, as well. She also commented on accessibility issues on BART, requesting that BART continue with the elevator attendant program to help people navigate stations safely.

12. Update on the 15 Third Bus Study [NTIP Planning] - INFORMATION*

Hugh Louch, Deputy Director for Planning, presented the item.

Commissioner Walton shared issues encountered after the removal of the 15 Third bus stop service in 2007. His office called for bringing the Third Street service back to enhance service on the Third Street corridor and in Bayview Hunters point, and to eliminate the delays and inequities that exist within the T line. Commissioner Walton thanked Hugh Louch and team for conducting the study and the for listening to the feedback and proposing opportunities to get the 15 back.

During public comment, Steven Miller shared his concerns with the Third Street bus line being restored, particularly running solely on Third Street. Specifically, he stated that the lanes are not wide enough to accommodate the buses and will cause more traffic build up and cause potential side-swip collisions. He expressed his preference for making improvements to the T-Third since so much money has already been invested in the rail line.

Cristina Calderón Olea, San Francisco Department of Public Works project manager, presented the item.
