# Muni Metro East Expansion Phase 2 - MME & 1399 Marin Interim Improvements (SFMTA) Design

Prop K request: \$1,899,677

Total cost: \$7,543,044

Develop two sites for interim storage and maintenance of trolley coaches during redevelopment of Potrero maintenance yard

- 4-acre empty lot adjacent to the Muni Metro East (MME) light rail facility
- Bus yard at 1399 Marin
- Open for use March 2024, prior to demolition of existing Potrero facility



# Great Highway Traffic Management (SFMTA) Construction

**Prop K request: \$424,971**

**Total cost: \$568,766**

Install calming measures at strategic locations adjacent to the Great Highway in District 4 to divert traffic to key corridors while improving safety conditions for all road users

- Reduce traffic volumes and speeds
- 25 speed cushions, 1 speed table, 2 stop signs, 6 changeable message signs
- Open for use March 2021
- Special Condition

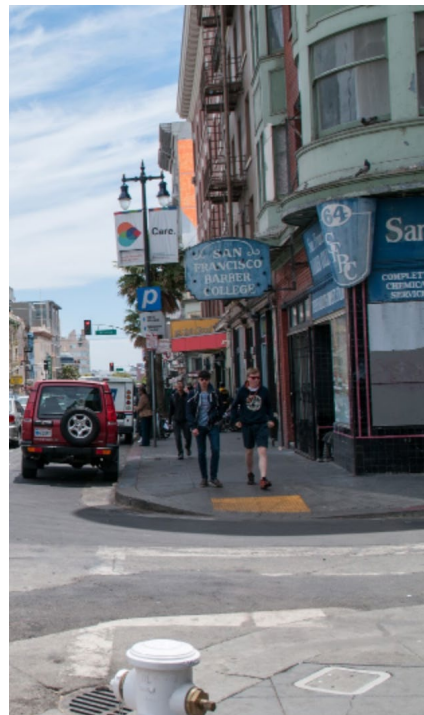


# Safe Streets Evaluation Program (SFMTA) Planning

Prop K request: \$250,000

Evaluate traffic calming, bicycle,  
and pedestrian safety projects

- Pre- and post project data collection
- 20+ projects, including Quick-Builds and COVID-related Slow Streets
- Database for ongoing evaluation
- Annual Reports for 2020 (by June 2021) and 2021 (by June 2022)



# Tenderloin Traffic Safety [NTIP Capital] (SFMTA) Construction

Prop K request: \$177,693

Total cost: \$177,693

Install 395 signs to reduce neighborhood speed limit and restrict turns on red to reduce conflicts and injuries

- Reduce speed limit from 25 to 20 miles per hour
- No turn on red prohibitions at 54 intersection
- Outreach through variable message signs, posters, flyers, online posts
- Open for use April 2021

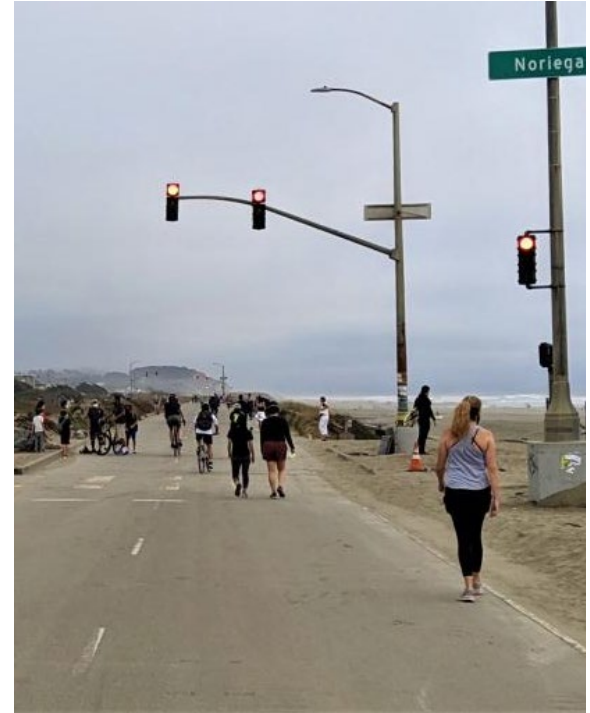
# District 4 Mobility Improvements Study - Additional Funds [NTIP Planning] (SFCTA)

Prop K request: \$60,000

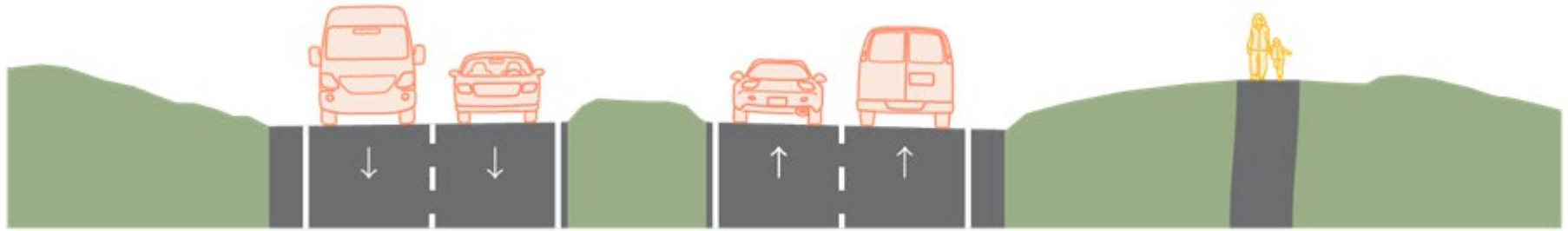
Total cost: \$190,000

Analyze future promenade and roadway concepts on the Great Highway between Sloat and Lincoln

- Additional scope to existing study
- Recommendations will consider multimodal transportation impacts and benefits, open space opportunities, operational challenges, cost
- Final report to the board in mid-2021

Four-lane Roadway



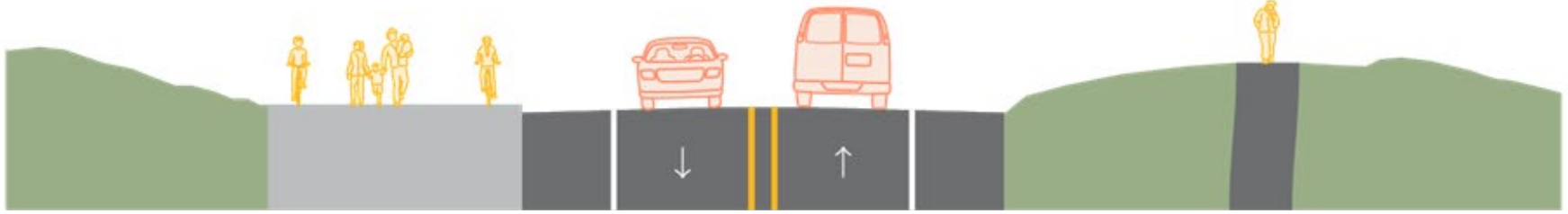
Full Promenade/Complete Vehicle Closure



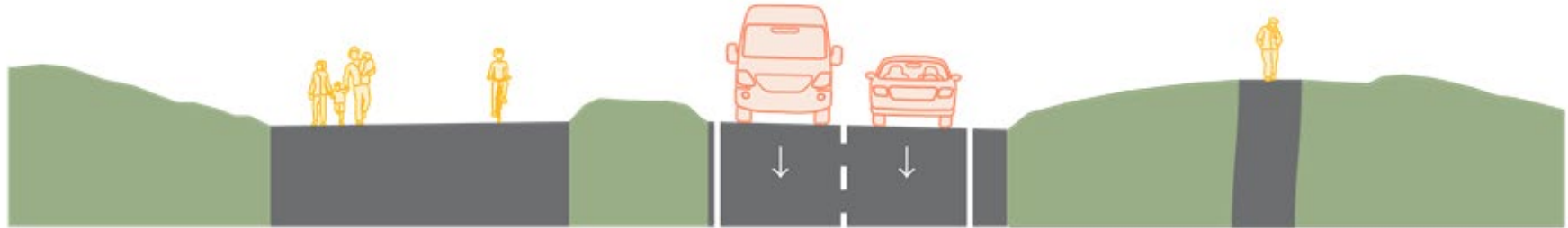

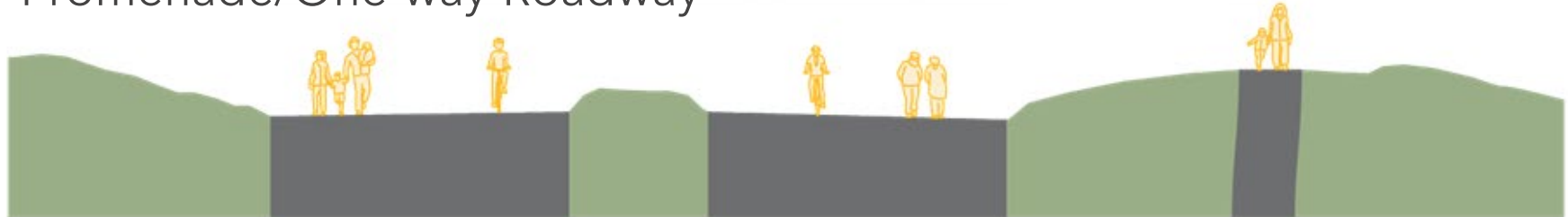
