I strongly support Howard Chabner's sentiments expressed to you:

Please reopen JFK Drive to cars when the temporary, emergency order forbidding cars expires, except, as before the pandemic, for the eastern part on Sundays and some Saturdays.

Before the pandemic, a large percentage of visitors to Golden Gate Park came in cars, including San Franciscans, people who live elsewhere in the Bay Area, and tourists from around the world. Those who relied on cars include seniors, people with mobility and other disabilities, families with children, and residents from places within and outside San Francisco where driving is the only feasible option. Before the pandemic, JFK Drive was open to all transportation modes, including cars, except the eastern part was closed to cars on Sundays and some Saturdays. That was a fair compromise. In addition, there has been a parking-protected bike lane in both directions on JFK Drive for years (the creation of which resulted in the elimination of many parking spaces).

The closure was imposed by executive order of Mayor Breed at the beginning of shelter-inplace on a temporary, emergency basis in order to provide more space for social distancing. In essence, this has closed much of Golden Gate Park to anyone who can't walk or bike in, which is inequitable, but it was imposed quickly and justified as one of many temporary measures to deal with an unprecedented public health emergency.

Permanently closing JFK Drive to cars would create a permanent access barrier to Golden Gate Park for countless numbers of people, including many seniors, people with mobility and other disabilities, families, and people from places where driving is the only feasible option.

The closure of JFK Drive to cars during the pandemic has been touted as a success by some, and used to argue for permanent closure. But it hasn't been a success for those who have been unable to access Golden Gate Park because of the closure. It may be possible to measure the number of pedestrians and cyclists in the park, but it is utterly impossible to measure the number of people who couldn't go there because of the closure.

Permanently closing the eastern part of JFK to cars would permanently eliminate hundreds of parking spaces. Increasing the number of blue zones elsewhere in the park and in the surrounding areas would be insufficient to compensate for the loss. Disabled people parked not only in the blue zones on JFK, but in regular spaces also, as we do throughout the city. When JFK was open to cars, people who couldn't walk, or couldn't walk far, could park close to destinations such as the Conservatory of Flowers, AIDS Memorial Grove, Dahlia Garden, the Rose Garden and others. With permanent closure, they will never be able to. Moreover, increasing the number of blue zones elsewhere would do nothing for the countless number of people who may not be disabled but rely on cars to get to the park.

The City can't make the temporary, emergency closure of JFK Drive permanent without doing an environmental impact report. (The original bike plan was tied up in court for years because the City refused to do an EIR.) And you can't do an EIR about closing JFK without first doing a traffic study of the surrounding areas. One example of the environmental impact on the surrounding areas is the increased congestion on Fell Street from Masonic to Stanyan since JFK Drive has been closed. Any study also must include the impact of losing hundreds of spaces in GGP on parking in the surrounding areas. And it's impossible to do a meaningful traffic study until after the pandemic emergency is over, because current conditions aren't representative.

Closing JFK to cars permanently would violate Title II of the Americans with Disabilities Act. And the City has a mixed record in defending against ADA lawsuits.

In my own words, I must say that this policy is absolutely cruel. It seems that city officials have a very calloused attitude towards those of us who cannot walk very far and whose knees cannot bend so that we cannot take even one step to get into a jitney, such as the ones provided for the disability community to try to access the lighted trees this past winter. Waiting in inclement weather for a jitney is no substitute for being able to drive along JFK Drive, and drive up in front of the Conservatory of Flowers, park on JFK Drive, and watch the light show at night, in the comfort of the family car. In fact, the jitney option is not a real option at all, because for elders having to wait in the cold and be transported in the cold to a site is just not feasible. We are effectively shut out of the park.

It seems that City policy just aims to serve the able-bodied who live close to Golden Gate Park or who are athletically fit enough to bicycle to it. But Golden Gate Park belongs to all of us. including those families with elders and children who might like to drive to and through the Park

from the outer districts of the City or from the East Bay or San Jose. The new director of the deYoung Museum has made admission free to all Bay Area residents on Saturdays. The deYoung includes a world-renowned permanent exhibition of Native Arts of the Americas, Oceania, and Africa. Viewing these exhibitions could be life transforming for thousands of Bay Area families. Please keep access to Golden Gate Park open to everyone. Be fair, Respect. Be kind.

As the pandemic restrictions are loosening, San Francisco is starting to reopen, and debates are ongoing about what a post-pandemic San Francisco should look like, it's critical to keep in mind that many people who live in, work in, recreate in, visit or otherwise travel to San Francisco rely on cars. This includes many seniors, people with disabilities, families, those who live in areas (within and outside of San Francisco) without plentiful and effective public transportation, contractors, housekeepers, tradespeople, salespeople, caregivers, nurses and technicians.


Attached are a memo I wrote about why people with mobility disabilities rely heavily on cars, and a letter I wrote to Peter Hartlaub of the Chronicle in response to his piece last summer urging that San Francisco radically de-escalate car infrastructure and take steps toward becoming a car-free city.

Temporary, emergency measures taken in response to an unprecedented public health emergency should be just that - temporary. Reduction or denial of access that may have been tolerated for a relatively short period of time during an emergency must not be allowed to become the new normal.

Dear Chair Mandelman and Commissioners,

We are San Francisco's member-supported advocates for affordable, efficient, and always growing public transit. As such, we're concerned about the current proposal for the return of Muni service as San Francisco begins to recover from the state of emergency.

We understand there are many challenges to when, how, and where Muni service is restored. At the same time, it is evident that Muni risks continuing to be dangerously behind demand. We see crowding and pass-ups. We know too many people are still left behind by suspended service. Even as vehicle capacity restrictions relax, we are concerned that Muni won't have the capacity to meet demand.

With uncertain future demand, we know service may not look like it did prior to the pandemic. We are seeing some routes getting more service than ever because there isn't competition for school and downtown peak service. We do not want to go back to leaving those riders behind as they were before. While downtown demand may not recover immediately, it also might; at some point schools will return; and we know that travel and tourism might increase quickly as people find it safer to do so.

Even as travel patterns shift, maintaining 70% of pre-pandemic service hours will not be sufficient to serve riders' needs through 2021. Proposing 85% service restoration through 2022 is also insufficient, especially considering that pre-pandemic service hours delivered were not 100% of what was scheduled and needed.

In a transit-first city, we need to allocate resources to make sure Muni service is there when (or before) people need it. We know that transit is essential. Returning full transit service as soon as possible is essential to reviving our economy, to serving our most vulnerable neighbors, and to mitigating widespread dependence on private cars. We need to build back the transit system required for a sustainable, equitable, accessible future.

SFMTA can't solve this on its own. We need to make sure every available dollar is being used to restore service so that SFMTA is able to implement aggressive hiring plans, and to implement transit priority across the city to serve more riders while saving money.

We urge the SFCTA to support a speedy return of service and work with SFMTA to lay out a clear, funded path to 100% of pre-pandemic service as soon as possible.

Permanently closing the eastern part of JFK to cars would permanently eliminate hundreds of parking spaces. Increasing the number of blue zones elsewhere in the park and in the surrounding areas would be insufficient to compensate for the loss. Disabled people parked not only in the blue zones on JFK, but in regular spaces also, as we do throughout the city. When JFK was open to cars, people who couldn't walk, or couldn't walk far, could park close to destinations such as the Conservatory of Flowers, AIDS Memorial Grove, Dahlia Garden and others. With permanent closure, they will never be able to. Moreover, increasing the number of blue zones elsewhere would do nothing for the countless number of people who may not be disabled but rely on cars to get to the park.

I live close enough to roll to the park, which I do often when the weather is good, and it is truly delightful. But even though I live close, I'm not able to roll there in cold or rainy weather, or at night. When my mother, age 91, visits from Chicago, we drive to the park to go to the museums and gardens. She can walk short distances, but it isn't possible for her to walk there no matter how good the weather.

Weather matters. Many visitors, whether disabled or not, are unable to stand in the rain or cold waiting for a shuttle, and are unable to walk long distances in the rain or cold.

Terminology matters. Rec Park, MTA and others refer to the days that JFK Drive is closed to cars as "Car-Free" days, which implies freedom, and implies that cars are bad. "Restricted Access" or "Car-Forbidden" would be just as accurate.

The City can't make the temporary, emergency closure of JFK Drive permanent without doing an environmental impact report. (The original bike plan was tied up in court for years because the City refused to do an EIR.) And you can't do an EIR about closing JFK without first doing a traffic study of the surrounding areas. One example of the environmental impact on the surrounding areas is the increased congestion on Fell Street from Masonic to Stanyan since JFK Drive has been closed. Any study also must include the impact of losing hundreds of spaces in GGP on parking in the surrounding areas. And it's impossible to do a meaningful traffic study until after the pandemic emergency is over, because current conditions aren't representative.

Closing JFK to cars permanently would violate Title II of the Americans with Disabilities Act. And the City has a mixed record in defending against ADA lawsuits.

As a San Francisco resident and longtime educator at the de Young Museum please allow me to comment on the proposed closure of JFK Drive. Full and permanent closure of JFK Drive represents a highly entitled and mind bogglingly ableist view of parks and museum access. The de Young is a public museum, part of SF City and County. The museum adds to the economy of SF by bringing in visitors from around the Bay Area as well as provides services – free of charge – to thousands of families, school children, people with disabilities, and low income communities. To have SF government limit access to the de Young truly baffles me. It does not make sense to encourage children to ride bikes through a necessary loading dock. It does not make sense to ask people with disabilities to park further away than they can walk or rely on a shuttle that currently provides no seating at pick up spots, and only runs on weekends. Much more thought needs to go into a workable solution for all. I strongly believe it is not appropriate for able bodied, middle and upper income individuals to shame people who: have disabilities, are elderly, low incomes, or who live outside the city for driving. The de Young museum fully supports bike riding and walking in safe and pleasant conditions, but I must ask why - in an area as large as Golden Gate Park - has JFK Drive with its 17 ADA parking spaces and over 300 free parking spaces close to Music Concourse attractions, been selected? I humbly ask you to consider all San Franciscans in regards to this matter. Thank you very much.

I cannot believe you are even contemplating closing JFK Drive permanently when it is one of the main arteries giving access to two major SF museums as well as the Tea Garden and Botanical Garden!! This would badly effect all people, but especially the elderly and those with a disability.

Although I am 80, I can still drive and walk a short distance. When the Museum is open, I visit the de Young Museum several times a month and always park on JFK Drive and walk the short distance to the museum. If JFK is closed, where do I park? If the only available parking is blocks away, can I walk far enough to reach the museum and still have energy to walk in the galleries? I cannot afford the very expensive garage. Friends say never park on Fulton as cars are broken into all the time. If there are less roads open in the Park, parking will be harder to find. The GG Park should be for all people - those who drive, take the public bus, ride a bike, walk, use scooters, etc. DO NOT limit access to the public park. We need to expand accessibility everywhere, including in parks and cultural institutions.

Now that the de Young Museum is open, open JFK Drive and reinstate the accessible parking.

A shuttle is NOT the answer. People with vision disabilities, learning differences, and other cognitive issues would have a great deal of difficulty locating Shuttle stops. They might not be able to read or process written information about riding the Shuttle or locating any of the stops. People with mobility disabilities, or those dealing with chronic pain, would not be able to stand and wait for the shuttle, and probably have great difficulty getting on and off the Shuttle. Drivers would have to be consistently trained in how to safely, appropriately and courteously operate the Shuttle's lift. Shuttle frequency would have to be dramatically increased to accommodate the greatly increased demand from Museum elders or goers with disabilities.

One final note about giving priority to bicyclists. I have nearly been hit by several while walking in a GGP crosswalk. Many bicyclists do not obey traffic laws: they ride through stop signs, red lights, do not signal. Put some effort into educating bicyclists and giving them tickets when they disobey traffic laws rather than letting them run wild in SF!

My name is and I am the Access Manager at the deYoung Museum. I am also a person with a dual disability as I am both hard of hearing and legally blind.

I am contacting you in both my professional and personal capacity to express my deep concern and shock that JFK Drive East has been completely closed to vehicles and is being considered for permenant closure.

>From a professional point of view, the closure severely and negatively impacts accessibility for our visitors with disabilities to visit the de Young Museum, and much of the east end of the park. Not only does the closure significantly decrease the number of Blue Zone Handicapped and free parking spaces inside Golden Gate Park, including 30 which are accessible to the de Young, but it also impacts all people with disabilities to physically visit the museum, a city institution that is required and enforced by ADA law to provide access. People with disabilities have many specific considerations for which access to JFK Drive can accommodate them. Closure of the road would simply be a discriminatory and ableist move, going against what the ADA law requires because there is no reasonable accommodation to work around this. Shuttles will not work for many people who are wheelchair users or have other physical disabilities, people who are sight and/or hearing impaired, and people who are cognitively disabled because the shuttles are not equipped to handle very specific considerations. Additionally during COVID, such contained spaces are to be avoided.

The road closure also limits access for underserved populations in the community who may be burdened physically, such as Seniors, or by the costs of paid parking, such as the low income population, over which the de Young has no control.

As a hard of hearing and legally blind individual, the road closure also impacts me personally because I rely on either a ride to get to work (which is the deYoung Musuem), where I am dropped off at the front of the museum or the #44 bus which also drops me off in front of the museum. Not having this access means I will be putting myself more at risk of danger, as a significantly sight impaired individual, having to walk further distances with random people traffic in order to reach either private or public transportation. The road closure can potentially increase the potential for foot traffic accidents for someone such as myself.

I hope that you will consider showing your support for restoring JFK Drive access for the disability and underserved communities, helping ALL people access the park and the City's museum.

You have no idea how much thIs road closure would affect myself and many, many others. If you close JFK drive where will everyone park? I haven't even touched on the pleasures of driving through the park and visiting various parts of the park that would not be possible if you close this road. It will be a nightmare. Please don't do this. Disabled people like to enjoy the park and the museums and you're not considering us and our needs with this closure. Because you don't have our needs. Which are very different from able bodied people.

My name is Deborah Costello. I took my 90-year-old mother to see the Frida Kahlo exhibition at the de Young Museum. My mother cannot walk very far without tiring. We had planned, as always, to park in a blue zone behind the museum. We were shocked to see that parking there is no longer an option. As we had timed tickets and could not spend a long time searching for neighborhood parking, we parked in the garage.

The Frida show was amazing. What an individual; she did not let a disability stop her from pursuing her dreams! Both my mother – who was able to make it through the entire exhibition without a wheelchair –and I were thrilled and inspired by the show. This feeling was dampened when we returned to the garage and paid a \$20 parking fee. My mother and I both live on fixed incomes. When told that the wide street behind the museum was closed for bicyclists, I could not believe that this tradeoff is being made.

I am reaching out to the Mayor's Office on Disabilities because I am gravely concerned that Recreation and Park and the SFMTA do not care about people with disabilities, the elderly, or those living on fixed incomes. Hello my name is Maureen Murphy. I'm a native Sunseter growing up next to Golden Gate Park. As an adult I purchased my home in the Sunset again living adjacent to the Park. I have enjoyed all areas of the Park over the years but currently I enjoy the de Young museum. I have become disabled 7 years ago and now live a very limited income. Before I had to retire on Disability I worked for the California Department of Transportation (Caltrans) for 23 years. I am a Civil Engineer and worked as a Transportation Engineer in various Departments. I worked with SFMTA on some joint projects in San Francisco. I have a Master's Degree from SJSU Mineta Transportation Institute, Department of Business in Transportation Management.

It saddens me as the Americans with Disabilities Act celebrates it's 30th Anniversary this year and the City of San Francisco is becoming less accessible for the disabled. Parking is disappearing all over the City and disabled people are paying the price becoming more home bound. It also saddens me that after 30 years of the ADA there is still resistance to compliance and the only way to achieve compliance is by litigation.

I want to express my concern that JFK Drive East has been completely closed to vehicles. The closure negatively impacts accessibility for individuals with disabilities to visit the de Young Museum, and much of the east end of the park. The closure significantly decreases the number of ADA and free parking spaces inside Golden Gate Park, including 30 which are accessible to the de Young. This also limits access for underserved populations in the community who may be burdened by the fact it is only in a wider ADA space where they can park. Just because a car will fit into a regular parking space does not mean it will suit an individual with disabilities.

Golden Gate Park has always been my Go To place and I was happy to say for the most part I had been able to utilize ADA/disabled parking or a space that met my needs for parking.

The de Young Museum has always been my favorite museum in SF and had remained a public space that I could easily access with ADA/disabled parking and could move around quite easily inside the museum. Now that pleasure of visiting the de Young is being taken away from me with the loss of the 30 ADA/disabled parking spaces that were directly accessible to the de Young. This is not fair. To take away from the Disabled Community, if anything the City should be adding to the facilities needed for disabled people.

The City is already guilty of packing people in dwellings increasing the density while removing parking spaces and allowing contractors to get rid of parking spaces in their new buildings if they pay a fee or add a low income unit

This is setting the entire City up to park in their driveway and most are blocking just

enough of their driveway that it is breaking the law as a disabled person would have a hard time getting around your car that's in violation.

I used to enjoy the safe, quiet, quarter mile walk every morning when parking on JFK Drive was permitted, but now I typically have to walk a half mile or more in the morning through heavily trafficked neighborhoods and intersections, and navigating difficult hilly sidewalks and trails in Golden Gate Park to get to the Museum. This is unpleasant now in good weather, but will be even more challenging soon when the rains begin. Even if I were to qualify, I don't want a handicapped parking placard because I think they should be reserved for those more disabled than myself, but a safer, shorter walk to and from my place of work is important to me. This can be accomplished by simply returning to the parking arrangement on JFK Drive that was in place previous to the COVID 19 restrictions.

My name is _______. I am a long-time resident of San Francisco. I live near the eastern end of the Panhandle. I am a blind retired physician, and a long-time member and patron of the DeYoung Museum. With the re-opening of the DeYoung, I have only recently become aware that JFK East has been closed during the Pandemic. I was shocked then saddened to learn that plans are afoot to permanently close JFK to vehicle traffic.

Many disabled people, particularly those with limited mobility and low incomes, count on their families or friends to accompany them to the DeYoung and park near its entrance.

Disrupting traffic on JFK and eliminating the free parking spaces near the museum creates a serious impediment for them and eliminates an essential accommodation. The disabled spaces in the parking garage are not an alternative for the disabled who cannot afford to park there.

When I discovered that the bicycle coalition and neighborhood associations near the park have pressured the MTA and Park and Rec to close the JFK Drive by the museum, I was infuriated. Such a change pits privileged, able bodied bicyclists, skateboarders, and roller skaters against the aging and disability communities. Closing roads effectively eliminates the disabled

It appears that Park and Rec and the MTA have not thought through the needs of the entire community. I am counting on the Mayor's Office to set them straight. San Francisco deserves better. Do not diminish the disabled.

Please reconsider the permanent impact this proposed road closure would have if implemented, to our rich and diverse disabled community, and make what is the right and inclusive decision by rejecting a permanent ban of private vehicular traffic through Golden Gate Park. Thank you.

Though this park is my safe haven, it is not only mine. It belongs to all of us who live here and who visit San Francisco. It should be accessible to people of all abilities. Able and disabled bodies should have equal access to all places in the park. Although I understand wanting no cars and traffic, to close the roads denies access to all people who are unable to walk to the museums for mobility reasons, orientation, or stamina.

I am surprised that a city like San Francisco that prides itself on welcoming peoples from all backgrounds, abilities, and differences is considering changes in the park use-age for the enjoyment of just the able-bodied. One of the reasons I live in this city and pay the high price of doing so is the superior access to transportation and information. The spirit of this city is distorted when it is assumed that all who live here can walk independently, or ride bicycles. That all of us have the same abilities.

If the argument is that museums are elitist institutions therefore the use of the road to access it for bicyclists, skaters, and pedestrians is a more democratic proposition, then one should be paying attention to the steps the DeYoung is making towards inclusion. Though there is always room for improvement, the DeYoung is fighting to cater to all abilities and differences by creating free days, highly descriptive tours, welcoming children, providing dedicated deaf and hard of hearing tours, working with Veterans with disabilities, welcoming local artists, artists with disabilities, and so much more. To think that because a person is blind, or deaf, or paraplegic, or has dementia cannot derive pleasure and benefit from visiting the museum is just selective ignorance. To create barriers such as limiting free parking space or moving these spaces far from the entrance of the museum is just cruel.

My name is Jeanne Dorward and I'm a resident of San Francisco. I'm writing to express my concern that the temporary closure of JFK Drive East may become permanent. It was one thing to close this part of JFK while the institutions at the east end of Golden Gate Park were closed due to the pandemic. It is quite another to continue this closure now that both the de Young and the Conservatory of Flowers have reopened and the California Academy of Sciences has opened to its members and announced its reopening plan for the public. The closure of JFK Drive imposes an unnecessary hardship on people with disabilities since it reduces the number of ADA and free parking spaces inside Golden Gate Park. It also limits access for the underserved portion of our population who may not be able to afford the paid parking in the garage under the concourse, the cost of which is not controlled by any of the three institutions I cited. In addition to the expense the garage is often full so that those willing to pay are unable to enter the garage to secure a parking place.

Martin Luther King Drive does not have the capacity to accommodate those for whom JFK Drive is closed. JFK is already closed every Sunday all year and if I recall correctly, from Tea Garden Drive west on Saturdays from approximately April through October. JFK Drive has bike lanes in both directions from the entrance at Stanyan so bicyclists have a route of their own. I love Golden Gate Park but it's important to remember it's an urban park with urban attractions that are inspirational, educational and highlights of San Francisco. Most of these are clustered at the east end of the park and it's not fair to the disabled and underserved to be barred from using JFK Drive.

I don't think either SFMTA or Rec and Park are giving enough consideration to visitors to Golden Gate Park who aren't fit enough to bicycle there or walk a great distance. Greetings,

Thank you for taking the time to hear my story regarding JFK closure to benefit bicycle riders and leisure activity. In fact, this letter is about something much bigger than JFK. This street closure feels like just one more pixel in the big picture that is revealing how money talks and our largest minority population (people with disabilities) is occasionally heard in the process of making changes.

"welcome to the good life in San Francisco - if you are young, fit and earn a six figure income. The rest of you are inconvenient, so go away."

At least, that's the message I feel like I am receiving based on the decisions being made over the last few years. For instance, they took away a lane and made people back into parking spots in front of my apartment complex so that a bike lane could be installed. Now, it's not uncommon for me to barely have enough sidewalk for my guide dog to pass me through because parked vehicles overlap the sidewalk. When I take paratransit, I have experienced aggressive bicyclists cussing at my driver who dared to stop and let me off in front of my destination. When I step off the curb not able to see more than three feet in front of me, I hold my breath wondering if this time I am going to go down with an acquired brain injury like a friend experienced, just because some bicyclin\sts feel like they can "Sort of" obey the traffic laws. Add to that a sense of not being heard when MUNI diverted the 18 bus from Skyline, cutting off access to the Pomeroy Center from the Sunset and Richmond districts where many clients reside.

And now my story of access denial, microaggression and guilt for wasting space as a disabled woman in San Francisco continues with a new chapter as our fine fiscally and physically fit friends fight for more riding space in a park that seems, at least from my limited perspective, to already cater to bicyclists and pedestrians from the get-go.

I have been a member of the Fine Arts Museum's access advisors committee for the last fifteen years and have visited the museum via all manner of transport. Taking the bus wasn't always the best way. It's a very long ride from near Fort Funston and I fell down steps approaching from Fulton. And, well, at least the park is a beautiful place to get lost. Most often, I have visited with family and friends. I don't need close placard parking myself. But I drive in with friends with mobility disabilities and chronic pain. One in particular has about three blocks worth of walking on her legs and the closest free or placard parking is already far. I also visit the de Young museum via paratransit or ride-share. Being blind, I count on them to let me off at a consistent and reasonably close drop off point that not only allows me to find the museum entrance with ease but also to find my way back.

If JFK gets closed down, I'm pretty much getting kicked back to square one. Shuttle stops may prove challenging to find. I will have to wait for up to a half hour when transferring from

paratransit or ride-share to get the shuttle to the museum. Will the driver call my stop? Will the driver give me better directions than "It's over there."? And for that matter, why should I be expected to accept the added health risk of riding a shuttle potentially in close quarters with unmasked others just because I can't drive or look around to jog off to my destination?

Additionally, I have art students with developmental and intellectual disabilities who visit the park and museum as part of my City College classes and with their day programs. Many of them along with other groups travel to the museum via van service or program bus and cannot be dropped off to wait twenty minutes while their staff / driver finds a parking spot.

The important thing to note here is that, as with many access endeavors, the results don't just affect those of us who are blind or have other disabilities. Let's keep in mind the families with little ones in strollers, presenters with supplies, delivery people, decked out donors and beyond.

With the impending closure of JFK after everything else; I'm hearing, "Our fun is more important than your access." I'm hearing that, "Healthy San Francisco is for Healthy People and that obviously doesn't include you."

Since I visited my grandparents up here as a child, I wanted to live amidst and contribute to the vibrant culture of San Francisco. It's been twenty-five years since I proudly moved to what was the most blind-friendly and artistically welcoming city imaginable. Things have indeed changed.

So, let's help bridge the difference gap. Disability is one of many facets of identity and culture that make San Francisco sparkle bright as the gem it once was - um, is. And for what it's worth, there are lots of people with disabilities out there on the streets pushing to our physical limits, walking our dogs and riding from place to place on a very expensive set of wheels, some even on bicycles.

As a visitor to the park and the de Young museum I am writing to express my concerns about the movement to permanently close JFK Drive East to vehicles. While this has many benefits it impacts those disabled people who depend on their vehicle to access areas of the park this road serves, including the de Young museum. There are many disabled people that require the climate control, ease of use, or comfort provided by a personal vehicle. The closure will also significantly decreases the number of ADA and free parking spaces inside Golden Gate Park, including 30 which are accessible to the de Young. It will also limit access for who may be not be able to afford the costs of paid parking as well as those who cannot use the underground garage due to adverse health effects from the auto exhaust that builds up in this enclosed garage. I hope that you will consider showing your support for restoring JFK Drive access for the disability and underserved communities, helping more people access the park and the City's museum. You might look to Yosemite Valley as an example of how this can work. My name is ______, and I wish to express my disapproval of the permanent closure of JFK Drive for many reasons, but most of all because of the lack of accessibility to those rich sites of memory in the Concourse. Many a Sunday afternoon families took drives and and headed for the Band Shell for concerts, and the magic of the Aquarium, Hall of Science, Planetarium, Tea Garden and of course, the museum that thrilled with its wondrous contents-The Mummy in the entryway, the medieval armor, weaponry and like artifacts in one room; and another room filled with old-fashioned women's clothing, including a dress worn by Mary Lincoln and another belonging to Marilyn Monroe. And every man, woman and child who visited believed that all of it belonged to them. Our city, our park, our pride of place, our stake in the ownership of these treasures.

But those feelings no longer exist. The city is fractured, divided, and lacks a core both physical and emotional. The park is too far away from the City Center. The cost of tickets prohibitive for working families; the pride of place is now held by the fundraisers who rebuilt the new institutions, not the children and family beneficiaries to whom it all belonged.

I believe the present JFK street closure, with the ensuing limited transportation, resultant loss of parking spaces, and consequent isolation from the city at large, will only serve to create more distance and alienation rather than more accessibility; rather than bring people together, the closure will keep people away. While the parking garage was added to help entice visitors, again, the parking and admission fees are prohibitive for the average family. And finally, and most grievous of all, many segments of the citizenry, including the disability community have been denied access. The disability community has been callously and completely disregarded. If there is nowhere to park, and too far to walk, there is no access.

I hope you will reconsider the permanent closure of JFK Drive. Closed park roads on weekends can make sense, but anything else would be a denial of access for too many. And that is not the San Francisco way.
