Dear Supervisors & Commissioners,

Beyond the impact of the Great Highway closure, I'd like to address the negative impact in general of Slow Streets. I believe they're incompatible with a reopening City by forcing crosstown and cross-Park traffic from essential neighborhood alternate routes into a decreasing number of often snarled options.

I know that the Slow Streets program has a cadre of vocal enthusiasts, but at least in the Sunset and Parkside district, they're in relatively low density neighborhoods. have few pedestrian attractions and seem rarely used for purposes the program intended. They do, however, present neighborhood drivers going about their normal business with a frustrating maze of "keep out" signs that seem indicative of a City in lockdown.

I should also add that I'm sympathetic to the call by Supervisors Walton and Safai to re-examine Golden Gate Park closures. Park access belongs to everyone in the City, including the elderly, handicapped and families witth infants and small children. That also includes easy tourist access to the De Young, Academy of Sciences, Japanese Tea Garden and Conservatory, as well as the newly completed tennis courts. Autos and free parking are integral to that, and all stakeholders need to be considered before closing JFK, mainly for the benefit of cyclists (who already have multiple bike paths).

Similar issues can be raised ahout the Presidio, a multi-use urban expanse which has now also been severely restricted to everyone but cyclists and hikers. Just as important to me are the MTA closures of cross traffic routes through Golden Gate Park. Especially on busy summer weekends, we need these alternatives to 19th Avenue now that normal traffic is returning.

The downtown and financial districts are in a very fragile phase post-pandemic. The "no rhyme or reason" maze of Slow Streets, virtually shouts "lockdown" and signals the City has no real interest in commuters or a revitalized downtown. For those of us old enough to remember it evokes "Critical Mass".


