### LOCAL ISSUES

**Toll Affordability Programs - Outreach Activities Underway:** Two additional outreach opportunities are scheduled this week to advance the toll affordability programs for current workers and businesses. We will hold virtual workshops on June 22nd from 5-7 p.m. and June 25th from 12:30 to 2:30 p.m. The findings from this outreach and earlier April events will lead into final affordability program recommendations to be brought before the Committee in September. ### PROJECT DELIVERY

**Southgate Realignment Project Update:** The Transportation Authority administered I-80/Southgate Realignment construction project is approximately 50% complete and progressing satisfactorily on time and within budget. The project is scheduled for completion by the summer of 2022. Be advised the next three months starting on July 6, 2021 thru Oct. 3 2021 we will reconstruct the bike/ped path connection from the Caltrans' Landing through and under the San Francisco Oakland Bay Bridge (SFOBB) to the Macalla Road intersection to meet ADA standards. During this 3-month timeframe there will be restricted access beyond Yerba Buena Island (YBI) Vista Point, and during the month of September we will need to temporarily close access to YBI Vista Point to complete the reconstruction in this area. Please check our website for more details as the work progresses.

**Yerba Buena Vista Point Remains Open - BATA Funds Maintenance and Operations:** The Transportation Authority just executed the 5th amendment to the Yerba Buena Island (YBI) Vista Point Memorandum of Agreement (MOA). Vista Point is a popular venue that was constructed as part of the Transportation Authority led YBI Ramps project and opened to the public in May 2017. YBI Vista Point is strategically located adjacent to the San Francisco Oakland Bay Bridge bike/ped landing on YBI and serves as a major destination for bicyclists and pedestrians traversing to and from YBI and Treasure Island to the east bay. It includes rest area type facilities, a hydration station, bathrooms, and seating areas with spectacular views of the new east span San Francisco Oakland Bay Bridge. This MOA allows for the continued maintenance of these facilities utilizing funds from the Bay Area Toll Authority or BATA. We are working with the Treasure Island Development Authority and One Treasure Island in utilizing its local business vendor pool for maintenance and operations services.
