I strongly support fully re-opening the Great Highway. I am opposed to the 2 year pilot program to close it. San Francisco is returning to pre-Covid business and activities. The Great Highway must re-open now to resume its intended purpose, to provide a throughway on the west side of the city for people in motor vehicles to efficiently commute and transit north/south across the city. There are no viable alternatives at this time to carry those thousands of cars that were using it daily prior to the temporary closure, which are spilling out into the Sunset on to streets and neighborhoods never meant nor designed for that influx. Band aid fixes to try to mitigate the traffic, speeding and congestion problems have failed. Quite frankly, the money spent on those measures was a waste and would've been better directed towards more dire needs in the city like getting MUNI back on track to serve the people of this city as a dependable public transit system. Until our city has a transit system that actually works, to remove roads, so as to restrict car usage, doesn't make sense. A large contingent of folks are not going to walk, ride bikes or scooters to get around the city, so a well run public transit system is needed in lieu of cars. It's a sad situation that our city is a long way off from providing a solid and well run bus system. Until then, we need roads to carry cars.

District 4 is blessed with multiple areas for all sorts of fresh air and recreation. There is Golden Gate Park, Ocean Beach, a path along the Great Highway (used by walkers, joggers & cyclists), Stern Grove & Pine Lake, West Sunset, South Sunset and Sunset Recreation Centers and their fields, McCoppin Park, Parkside Park, Larsen Park with Sava Pool, Sunset Boulevard with adult fitness sites and Lake Merced just across Sloat Blvd.

We understood that during the pandemic, the City wished to have multiple areas of recreation so that people could socially distance. We understood that since there were almost no automobiles on the Great Highway at the beginning of the pandemic, this closure was a safe, short-term solution. But as the days and months have passed, and more automobiles have returned to the roadway, it has created an untenable situation.

The closure of the Great HIghway has affected the safety and quality of life of thousands of people in the Outer Sunset, the Richmond District and beyond. It has made quiet residential streets the shortest route between the Richmond District and points north, and the Peninsula and points south. Streets in the Outer Sunset, such as 46th Avenue, have become dangerous speedways. Frustrated drivers pass other cars in the middle of the street and drive around delivery trucks. Impatient drivers are not making complete stops at intersections. The constant starting and stopping of vehicles is creating more pollution.. The constant noise from the vehicles and the new speed bumps that are trying to slow down all the impatient and frustrated drivers can be heard at all hours. The noise from drivers honking at other drivers who are travelling at the speed limit is creating noise pollution. Removing one of the most popular throughfares between the Richmond (and North Bay) and the Sunset (and Peninsula) under normal circumstances is a bad idea. However, with the work on 19th Avenue, it is even worse, creating choke points, backing up traffic at various areas (Sloat trying to get on Sunset Blvd & 44th & Lincoln at the Chain of Lakes) and making travel untenable.

We have lived in peaceful sharing since the opening in 1929 of the Great Highway. The Great Highway is a main road connecting towns or and cities and functions as such for residents of the Sunset, Richmond, the Peninsula, and the North Bay.

There are paths on the side of the Great Highway that were designed to meet the need of pedestrians and bicyclists. Return to the Great Highway to its original purpose, a roadway for vehicles, not a walkway for pedestrians and a bike path for cyclists.

As a Richmond District resident, Senior Citizen, person with a disability, psychotherapist who contracts with the SFDPH, and environmentalist, I'm writing to urge you to reopen the Great Highway.

The closing of the Great Highway was an emergency measure that imho was never really needed in this area of many parks, beaches, paths and other recreational space. While I've walked on it myself on a few occasions, it's never been particularly well used. especially compared to the toll the closing takes on those needing to get to and from work (particularly the workers at the VA Hospital at Ft. Miley who we are supposed to be celebrating for their heroism during COVID but instead are adding time and congestions to their commutes.)

There is currently no public transportation across the West End of Golden Gate Park and the narrow Chain of Lakes Drive cannot accommodate the traffic that now inches is way across, creating exhaust problems for the cars and again enormous amounts of time to those trying to get across. A trip to my therapeutic swimming pool used to take 10 minutes in the Great Highway. Now I must leave an hour to get there! That means I have less time available to see the very needy Medi-Cal clients I attend to for the City.

Clearly, improvements in public transport, alternative routing and shuttle services need to be in place before closing the Great Highway ongoing should even be considered.

Dear Sir/Madam--

I am unable to attend the July 13 SFCTA meeting but would like to submit my comments about this important transportation artery for the city.

I am a former resident of the Outer Richmond neighborhood immediately adjacent to the Great Highway (now living in the Inner Richmond). At the time, I used the Great Highway each weekday to get to and from work down on the Peninsula. Not only is it a convenient and SAFE alternative to other transportation arteries south (19th Avenue), as a resident there I also felt safe using the walking and biking paths there recreationally. For decades before and in its immediate pre-pandemic state, it was an example of "if it ain't broke, don't break it..." It really was a Great Highway. The pandemic closure has converted it to the Great Wasted Space now reserved for a few niche uses.

The Great Highway's closure has had a negative impact on the residents of the immediately adjacent neighborhoods, on residents in nearby neighborhoods (like myself), and on all types of San Francisco residents in a couple of ways. First, for those who need it as an access point to roadways to the south, this is a temporary nuisance if one doesn't have to drive south daily (a temporary circumstance under pandemic office closures) but for those who hope to get back to work on the Peninsula, this is a major blocker to living in or even purchasing a home or condo in these neighborhoods. The use of the Great Highway under the pandemic closure has been restricted to those who are physically fit and highly physically mobile and have plenty of time on their hands. That is such a small number of residents that it is a real discrimination to those of us who pay the same property taxes here in San Francisco and have had a significant asset cut off from us.

Others have more eloquently voiced their support of re-opening this important vehicle traffic artery and fully family-friendly source of vehicular joy. All I know is that I very much miss being able to drive so many places in the city that have now been restricted and this is the one I miss the most.

Please re-open the Great Highway to all residents of San Francisco!
