Prop AA Vehicle Registration Fee Overview



San Francisco County Transportation Authority Prop AA Expenditure Plan requires adoption of a Strategic Plan including a detailed 5-year program of projects (5YPP) prior to allocation of funds

## 2012 Prop AA 5YPPs

- Fiscal Years 2012/13 2016/17
- \$24.8 million for 22 projects

### 2017 Prop AA 5YPPs

- Fiscal Years 2017/18 2021/22
- \$27.2 million for 19 projects

Prop AA Project Delivery Update Since inception, \$46.3 million allocated to 38 projects

- 22 projects open for use
- 16 projects underway

Prop AA Timely Use of Funds Policy



San Francisco County Transportation Authority Any project... that does not request allocation of funds in the year of programming may, at the discretion of the Transportation Authority Board, have its funding deobligated and reprogrammed to other projects through a competitive call for Prop AA projects.

Sponsors will have the opportunity to reapply for funds through these competitive calls, but will not be guaranteed any priority...
