I am a parent of a student at Sherman Elementary School and I am writing to ask you to vote to approve the rebuild project being discussed on December 7, 2021.

I had dropped off my child and two neighbor children at Sherman Elementary on November 10, about ten minutes before Andrew Zieman was hit and killed. I have walked and I continue to walk in and around that intersection frequently, with and without children.

I frequently drive down Franklin and I know the temptation to "sail" down that hill, going the same speed as the cars around me, catching all of the timed lights. It felt safe since we were all going in the same direction and trusted that intersections would be open. I now know that is not the case. There are a number of reasons a downhill driver might have to make a correction such as: a car changing lanes abruptly, someone running a red light, or a pet, child or debris in the intersection, etc. As we saw on November 10, 2021, avoiding an obstacle while speeding down Franklin can have a lethal domino effect. We must decrease speeds in that corridor so that drivers have time to react.

Please prevent a future loss of life and vote to approve the allocation of funds in support of the FY2022 Vision Zero Quick-Build program.

I have lived in the Marina for over 20 years, I am the parent of a 4th Grade Student at Sherman Elementary School and the President of the Sherman PTA. **I am writing to implore you to vote to approve the allocation of funds for the 'Quick Build' project on Franklin St. being discussed on 12/7/21.**

On November 10, 2021, a beloved member of our community, one of our daughter's teachers at Sherman Elementary, Andrew Zieman, was killed due to a car crash at the intersection of Union and Franklin. Our school community has advocated for traffic calming for many years without any action by the city. We have implemented as many safety measures as we can on our own, relying on hundreds of volunteers every year to keep our kids and the community safe. As a previous employee of SFUSD, positioned at Sherman Elementary School for over 10 years

I have been a witness to children and adults who have come fatally close to serious injury or death due to drivers going too fast in a school zone. I have seen doing bus duty in the early morning hours or mid afternoon makes no difference on how fast drivers will propel themselves down Franklin, sometimes veering on to Green or Union. There, the drivers are often met with parents crossing the street with their children. Often times these moms, dads, older siblings are not in the cross walk; many times they are. Brakes screech, terrified pedestrians run or back away on to the sidewalk. Just another close call.

The tragedy that happened early in November is not the first nor will it be the last if there are no interventions placed in this area.

Please consider a calming project for Franklin Street.

I am a long-time SF resident and parent of a 5 year old and an 8 year old attending Sherman Elementary School. "Mr Andrew" was known to my kids, especially my youngest. When I finally worked up the courage to ask him how he felt two days after the tragedy, he told me he was "sad and mad that somebody killed Mr Andrew." I am too.

On the morning of his passing — minutes before — my wife dropped them off at school. Every school day hundreds of kids walk by that intersection. It is also a busy commercial street and a bus corridor. There's no doubt in my mind that the design of the traffic flow is responsible for undue speed and extra risk at that intersection. A residential neighborhood with an elementary school is no place for a "raceway" as many consider Franklin St due to its design.

Good governance can save lives and this is a good opportunity for us to do the right thing. So I urge you to approve the rebuild project on 12/7. \$385k won't bring back Mr Andrew or take away the trauma felt by his family and an entire community, but it will be a step forward and it will be a teaching opportunity to our kids that civically engaged neighbors and strong public officials together can make a difference.
