



I agree with Patricia Arack's email. As I have commented before, in 45 years of voting in SF I have always voted yes to support Muni bonds, but no longer. I voted no on Prop A and will continue to vote no until the SFMTA stops pandering to the Bicycle Coalition and actually works on improving Muni and providing other inducements to switch from carbon based vehicles and not just close streets to cars. The recent slow streets program has no proof whatsoever that it results in a decline in carbon emissions since no environmental impact reports have been done. The SFMTA's own data on modes of transit show that vehicle use has gone UP from 2019 to 2021 so slow streets have not decreased car use at all. The slow Lake Street survey showed it did not have 75% support in the neighborhood yet the SFMTA continues to proceed with designs which include permanent concrete diverters. The Great Highway closure has been exacerbated by the failure of SF Park and Rec to clear sand which now, given the lack of good faith on the part of Park and Rec and SFMTA, probably means it's deliberate neglect by Park and Rec to further their bicycle agenda.

You need to reinstill trust in Park and Rec and the SFMTA. Street closures have polarized the city, created a backlash (as evidenced by the failure of Prop A) and inspired the proposed ballot initiative to reopen streets. What is the BOS response? A proposed initiative to override the re-open the street initiative. Really? Your response to the recall of Chesa Boudin was to change the recall requirements (which failed) instead of really listening to the voters and addressing our concerns.

No on \$800,000+ for more bicycle infrastructure. Start considering all SF residents, not just bicyclists, and improve public transit, make car use more efficient (no stop and go traffic and traffic diversions), create incentives for e vehicles such as building charging stations, etc.

I am writing to express my strong opposition to allocating close to \$1 million for unneeded bike racks. This is not how I want my tax dollars spent. There are already an abundance of bike racks and this money could be used in a way that benefits everyone - not just people able to ride bicycles. This is a perfect example of wasting taxpayers' money while not even addressing the real problems that need attention in this city.

SFCTA June 28 Approval of Bike Racks

Dear SFCTA Board:

I vehemently disapprove of the outrageous \$847,113 allocation for short term bike parking. Once again you are spending almost a million dollars on a small minority of bike riders in SF. This is why Prop A failed in the Sunset, and why you did not get your \$400,000,000 for SFMTA. It would have easily passed out in the Sunset if you had limited it to Muni improvements and allocated funds to EV promotion and charging stations.

SFMTA has used these priorities for allocation of the Transportation Fund for Clean Air:

Local Priorities

The Transportation Authority's Local Priorities for prioritizing TFCA funds include the following factors:

- 1. Project Type In order of priority:
 - 1) Zero emissions non-vehicle projects including, but not limited to, <u>bicycle and pedestrian facility improvements</u>, transit priority projects, traffic calming projects, and transportation demand management projects
 - 2) Shuttle services that reduce vehicle miles traveled (VMT);
 - 3) Alternative fuel vehicles and alternative fuel infrastructure
 - 4) Any other eligible project.

Please note the first priority mentioned in #1 is zero emissions non-vehicle projects. By 130 to 1, according to your own Climate Action Plan **the most effective method to reduce emissions is #3, Alternative fuel vehicles and infrastructure.** This should be #1, not #3. That and Transit improvement. Bike riding is the mode of transportation for a small minority; the vast majority of the population need their cars for work and/or for family needs. Many seniors and disabled residents cannot ride a bike. Yet, you persist in funding millions for bike riders and ignore the need to promote EV use. This is ableist and unconscionable.

Your priorities favor a small group, and neglect the large majority of workers and families who need to drive. This is wrong and unpopular with many San Franciscans. The Climate Action Plan plainly states that the most effective and efficient strategy to reduce GHG (greenhouse gasses) is to get drivers into EVs. Yet you persist in promoting as the highest priority, bike riding, when it is the <u>lowest effective strategy</u> to reduce GHG! What is the logic in that? Your stated goals in the Climate Action Plan against climate change are hypocritically defied by your actions.

I will continue to vote against any bond or proposition that includes any funds for bike riders and against any person running for office who promotes bike riding over Muni and EV funding. If you are serious about combating climate change, please start putting

our tax money toward real change for the environment.

You cannot effectively promote climate change by promoting a mode of transportation that affects such a small minority, cyclists. Stop funding millions for bikes. Instead, fund Muni transit so it is fast, efficient, reliable, comprehensive, and safe. Fund infrastructure for EVs; fund transition to EVs. Then I will believe you really care about climate change.
