Prop L Expenditure Plan

- Determines eligibility of projects and sponsor agencies through 28 programs
- Sets funding caps for each program over 30 years
- Allows for financing to accelerate project delivery
- Includes requirements such as a Board-approved **Strategic Plan** and **5-Year Prioritization Programs (5YPPs)**, as a prerequisite for allocation

2022 Transportation Expenditure Plan will help deliver safer, smoother streets, more reliable transit, reduce congestion, and more.

Prop L's 28 Programs

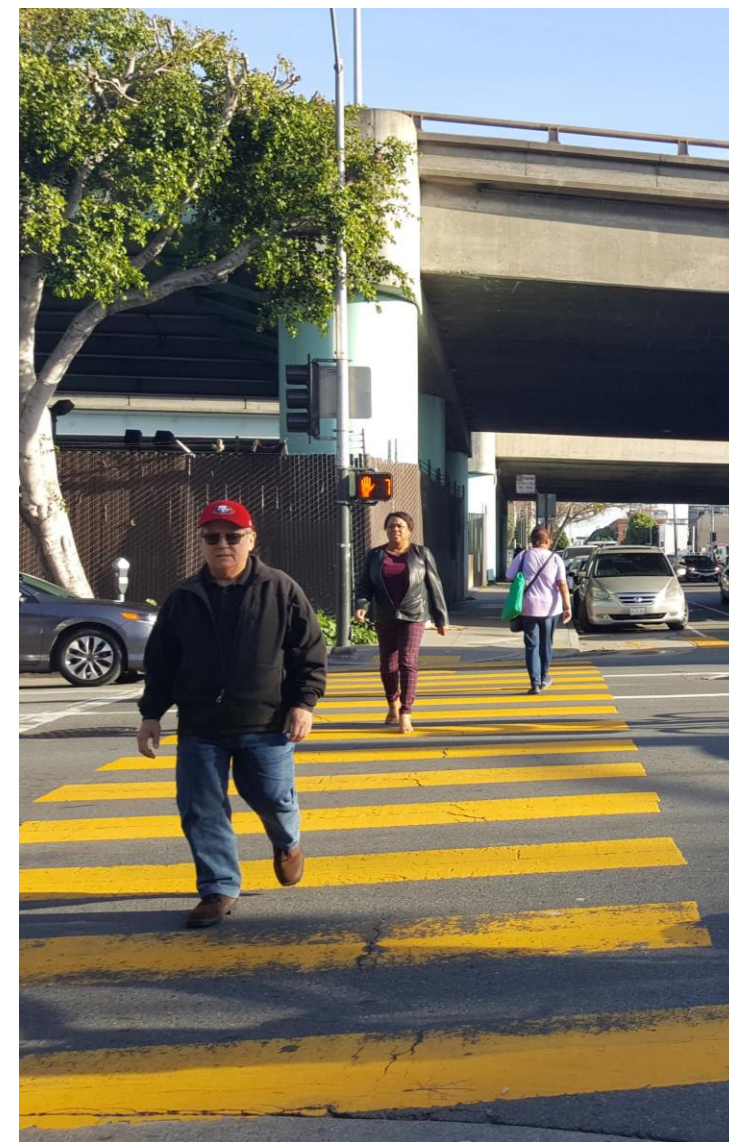
Each requires a Board-adopted 5-Year Prioritization Program (5YPP) before funds can be allocated.

2. Muni Rail Core Capacity
3. BART Core Capacity

What are 5-Year Prioritization Programs (5YPPs)?

- 5-year lists of projects for each program in the Expenditure Plan (28 total)
 - Includes scope, schedule, cost, and funding plan (plus leveraging) for each project
- Program Prop L funds to each project, with a cash flow reimbursement schedule
- Provide transparency for how projects are prioritized
- Provide certainty to project sponsors with committed funds for projects



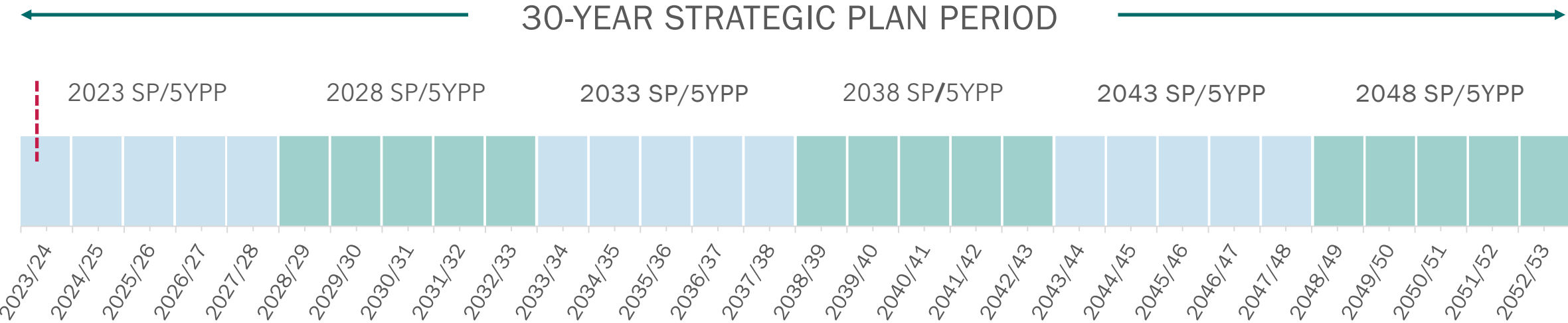
What is included in a 5YPP?

- 5-year list of projects
- Information on scope, schedule, cost, and funding, along with supplemental information to help score projects
- Project prioritization methodology to rank projects
- Performance measures to help inform future 5YPP development
- Other elements (e.g., summary of public feedback, project delivery report)



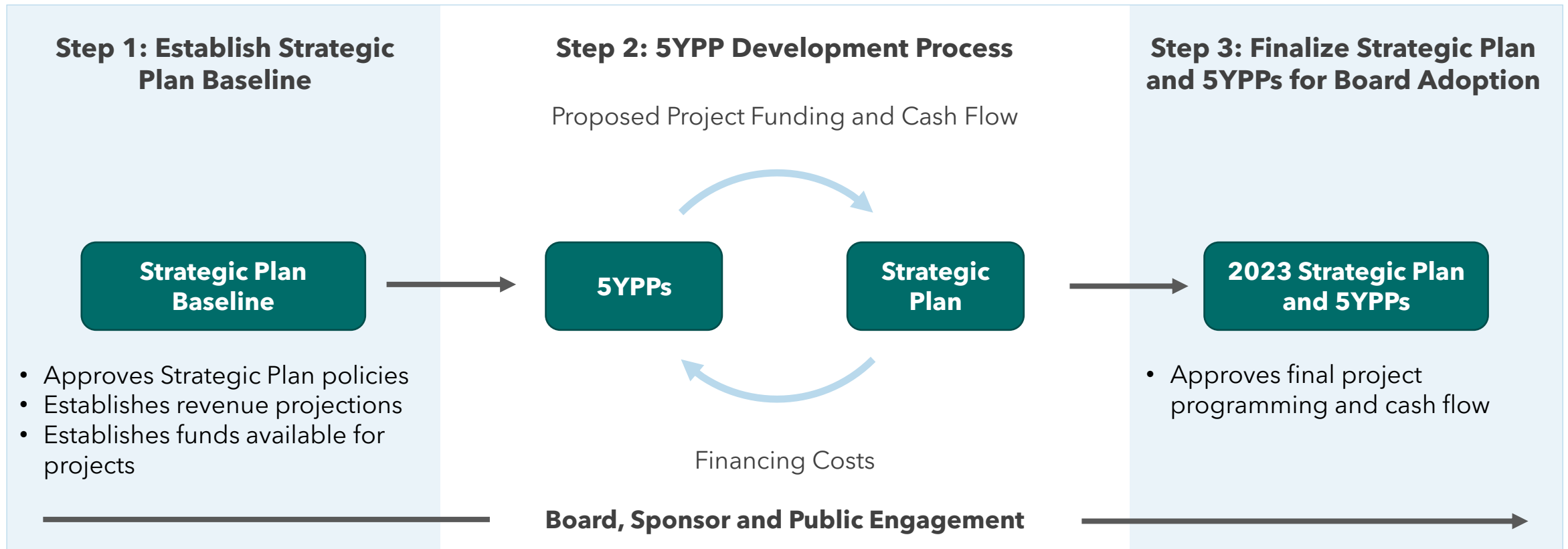
The Strategic Plan and 5YPPs Work Together

The Strategic Plan provides a 30-year financial look at Prop L.
The 5-Year Prioritization Programs (5YPPs) provide specific project funding detail in 5-year windows.



Strategic Plan / 5YPPs Development

Development of the Strategic Plan and 5YPPs is an iterative process.



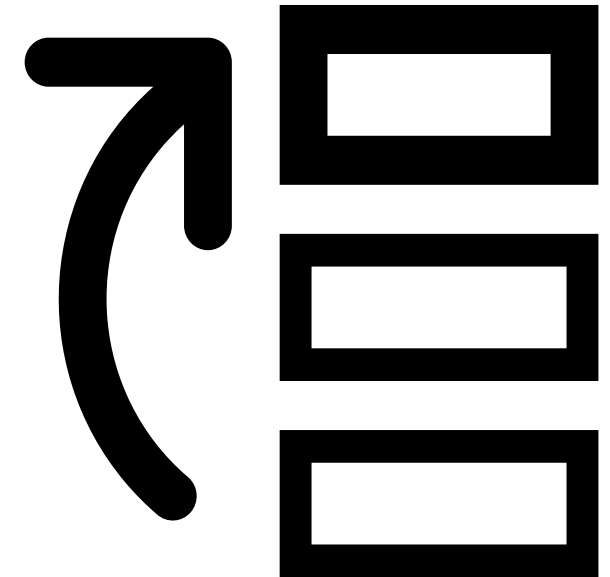
Selecting Projects

The Expenditure Plan requires that we consider:

- Relative level of need or urgency
- Cost-effectiveness
- A fair geographic distribution across the needs of our neighborhoods
- Level and diversity of community support
- Benefits to disadvantaged communities

We always consider:

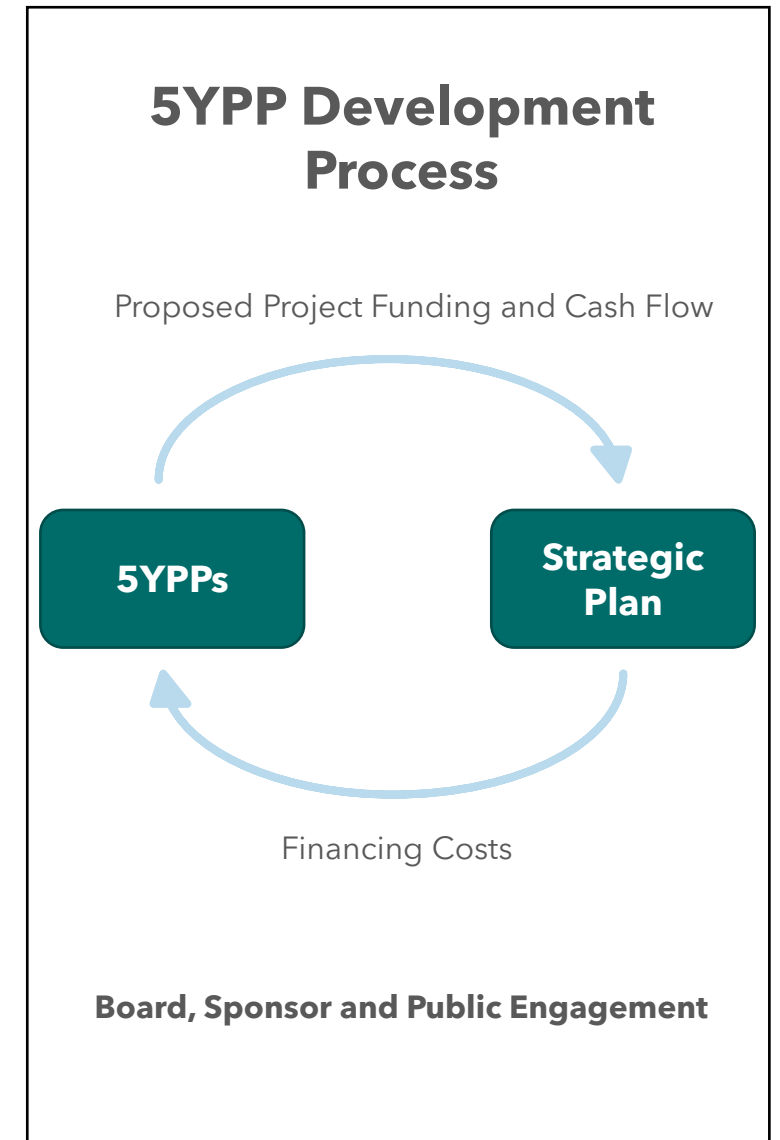
- Safety
- Leveraging other funds
- Project readiness



5YPPs Development Process

We evaluate individual projects and then 5YPPs as a whole to:

- Ensure Board and public input are addressed appropriately
- Establish costs and debt needs by program; ensure they fit within funding cap
- Coordinate across programs
- Support implementation of the Expenditure Plan and the San Francisco Transportation Plan



Strategic Plan / 5YPP DRAFT Schedule

Proposed Action and Next Steps

June 2023: Adopt the 2023 Prop L Strategic Plan Baseline (separate agenda item) and guidelines for the development of 5YPPs (this agenda item)

July - November 2023: Approve 5YPPs, likely in 3 groups; can start approving allocations for programs with approved 5YPPs

- First group will be small, for programs with urgent allocation needs

November/December 2023: Approve the 2023 Prop L Strategic Plan
