# DRAFT MINUTES

# **San Francisco County Transportation Authority**

Tuesday, June 24, 2025

#### 1. Roll Call

Chair Melgar called the meeting to order at 10:00 a.m.

Present at Roll Call: Commissioners Chen, Dorsey, Engardio, Fielder, Mahmood,

Mandelman, Melgar, Sauter, Sherrill, and Walton (10)

Absent at Roll Call: Commissioner Chan (1)

### 2. Chair's Report - INFORMATION

Chair Melgar reported that the California Transportation Commission announced staff recommendations for several Senate Bill (SB) 1 grant programs. She shared that the SFMTA Train Control Upgrade Project was recommended for \$41 million from the Solutions for Congested Corridors Program, and the Howard Streetscape Project was recommended for \$14 million from the Local Partnership Program. She expressed appreciation to the California Transportation Commission staff and looked forward to the funds being programmed and allocated.

Chair Melgar congratulated Caltrain for receiving the Rail Project of the Year award from the California Transportation Foundation. She stated that the project was a signature effort of the Transportation Authority's Prop K sales tax program and that it had transformed the Caltrain experience by delivering faster service, cleaner air, a more enjoyable ride, and a 37% increase in year-over-year ridership during its first seven months of operation. She stated that Caltrain Electrification was one of several major capital projects supported by the Transportation Authority through its sales tax program. She then congratulated the Finance Division, led by Deputy Director for Finance and Administration, Cynthia Fong, for once again receiving the highest rating from Fitch Ratings for the sales tax revenue bonds outlook and stated that this reflected strong stewardship of voter-approved funds by both the Finance Division and the Policy and Programming Division, led by Anna LaForte.

Chair Melgar reported that in early June, the California Senate and Assembly reached a state budget agreement that replaced the Governor's proposed \$1.1 billion cut to public transit with a \$750 million interest-free loan. She explained that this loan would help Bay Area transit systems, including Caltrain, Muni, and BART, avoid catastrophic service cuts over the next two years. She added that the Transportation Authority supported the effort to bolster regional transit. She then conveyed appreciation to Senator Scott Wiener, Senator Jesse Arreguín, and Assemblymember Mark Gonzalez for leading a coalition that secured and protected transit funding in the state budget. She said the Bay Area region had continued to collaborate in support of Senate Bill 63, which would authorize a regional transit measure for the 2026 ballot. She thanked Transportation Authority staff for closely tracking the issue and working with Metropolitan Transportation Commission and others to advocate for legislative changes

as needed.

Chair Melgar acknowledged that it had, unfortunately, taken 11 years to reach this point but expressed relief that the work was finally underway.
