Street Repair and Cleaning Equipment (SFPW) Construction

Prop L Request: \$300,000

Total Cost: \$368,000

Purchase one new front-end loader to replace equipment that has exceeded its useful life

- California Air Resources Board compliant equipment that meets current emissions standards
- Expected to be in service by June 2027



Public Sidewalk and Curb Repair (SFPW) Construction

Prop L Request: \$768,000

Total Cost: \$1,014,936

Repair damaged public sidewalks, curb and gutters, and angular returns not related to tree damage, at approximately 200 locations

- Locations identified through inspections, complaints, and trip-and-fall reports
- Public can request sidewalk repairs by calling 311
- SFPW expects to complete this work by June 2027

Curb Ramps Various Locations No. 19

(SFPW) Construction

Prop L Request: \$1,212,000

Total Cost: \$1,312,000

Construct 34 curb ramps and related sidewalk, curb, and gutter work at 6 intersections

- Locations primarily identified through public requests and SFPW inspections
- Open for use by September 2027

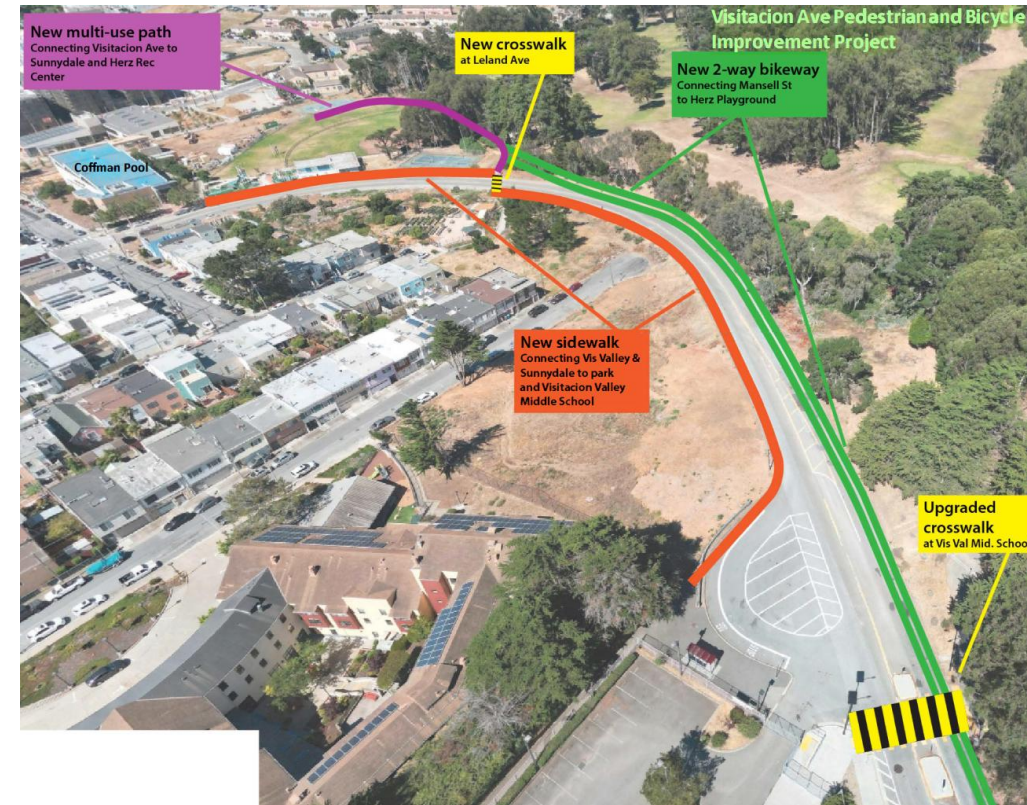
Visitation Avenue Bike and Pedestrian Safety Improvements (SFPW) Construction

Prop L Request: \$250,000

Total Cost: \$6,538,888

New pedestrian and bicycle facilities on the Visitation Avenue corridor in the southeastern section of McLaren Park

- Collaboration between Recreation and Parks Department and SFPW
- Includes new sidewalk, new or upgraded crosswalks, a two-way cycle track, and an off-road multi-use path
- Special conditions
- Open for use expected September 2027



Safe Streets Evaluation Program (SFMTA) Planning

Prop L Request: \$400,000

Total Cost: \$400,000

Measure performance of key traffic calming, bicycle, and pedestrian safety projects

- Evaluations will be completed by June 2028

Neighborhood Transportation Program Coordination (SFCTA, SFMTA) Planning

**Prop L Request: \$125,000 SFCTA
\$125,000 SFMTA**

Total Cost: \$250,000

Support for a NTP Coordinator role at the Transportation Authority and SFMTA

- Support Board members' efforts to identify potential NTP projects, develop project proposals, and conduct project delivery oversight
- Funds work through June 2027
