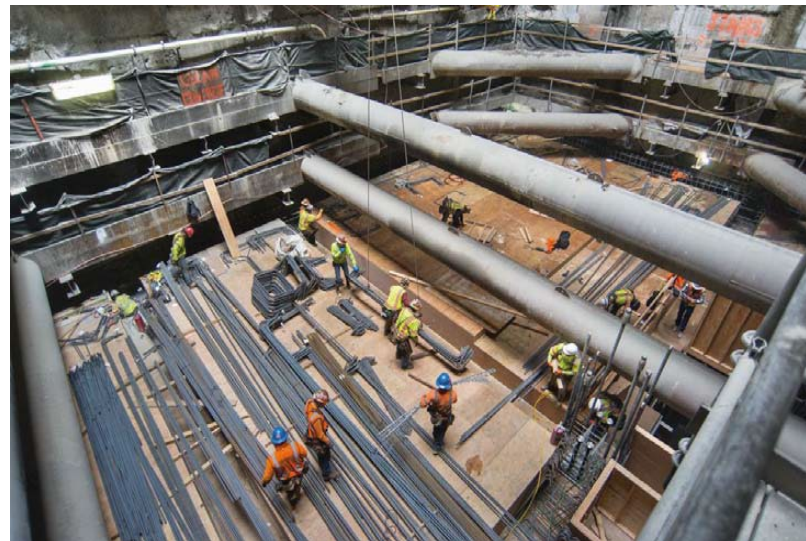

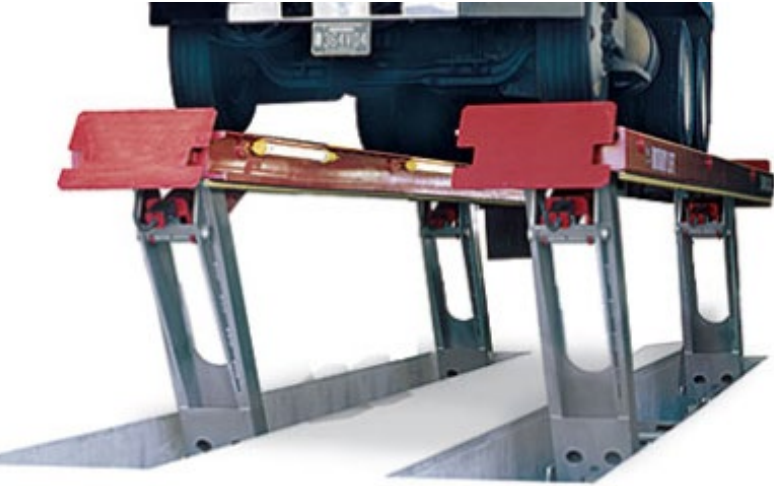
Central Subway (SFMTA) Construction



- ▶ **Prop K request: \$964,968**
 - ▶ Deobligated funds from prior fund exchanges
- ▶ **Along with two additional fund exchanges will direct \$21 million to help backfill Regional Improvement Program funds**
- ▶ **SFMTA is requesting an extension from FTA to revenue service date to December 2019**
 - ▶ 5-month schedule risk contingency



Presidio Bus Lifts (SFMTA) Construction



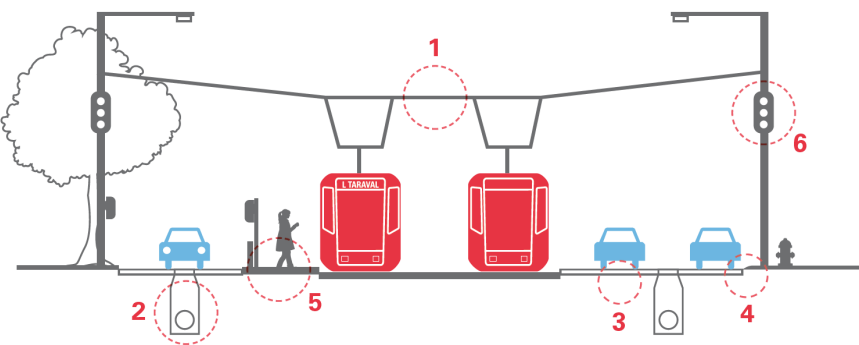
- ▶ Prop K request: \$4.4 million
- ▶ Replace 6 vehicle lifts, New roll-up doors and security gates
- ▶ Project will result in improved:
 - ▶ worker safety
 - ▶ productivity
 - ▶ facility security
 - ▶ fleet reliability
- ▶ Construction complete by December 2020



L-Taraval Transit Enhancements (Segment B) (SFMTA) - Construction



- ▶ Prop K request: **\$11.24 million**
- ▶ Replace light rail track and overhead contact system
 - ▶ West Portal to Sunset Blvd along Ulloa Street, 15th Avenue and Taraval Street
- ▶ Part of larger set of transit and street improvements
 - ▶ Transit stop optimization, boarding islands, bus bulbs, street resurfacing, and pedestrian safety
- ▶ **Construction Summer 2019 to Spring 2021**



16th Street Transit Enhancements (22-Fillmore Phase 2) (SFMTA) - Construction



- ▶ Prop K request: \$5.6 million
- ▶ Replace overhead contact system and install new communications infrastructure
- ▶ 16th Street from Church to Utah
- ▶ Part of larger set of transit and Vision Zero improvements
 - ▶ Transit bulbs, transit boarding islands, pedestrian bulbs, raised crosswalks, new traffic signals and curb ramps
- ▶ Construction Spring 2019 to end of 2020



Great Highway Terminus Narrowing (SFPW) – Design



- ▶ Prop K request: \$292,243
- ▶ Conversion of Great Highway from 4 lanes to 2 lanes at approach to Skyline
- ▶ Allows the South Ocean Beach Trail and parking lot project to begin
- ▶ Together, projects will provide a protected pathway for pedestrians and bicyclist, and parking for safe access to Ocean Beach and trails
- ▶ Design complete by December 2019
- ▶ Construction funding TBD

Taraval Street Pavement Renovation (West Portal to Sunset Blvd) (SFPW) – Construction



- ▶ Prop K request: **\$1.4 million**
- ▶ **26 blocks of pavement renovation, new sidewalk construction, and curb ramps**
 - ▶ **Ulloa Street (Forest Side to 15th Ave), 15th Avenue (Ulloa to Taraval) and Taraval Street (15th Ave to Sunset Blvd)**
- ▶ **Coordinated with L-Taraval Transit Enhancements**
- ▶ **Construction Summer 2019 to Spring 2021**



Alemany Blvd Pavement Renovation (SFPW) – Construction

- ▶ Prop K request: **\$1.75 million**
- ▶ Leveraging **\$1.75 million** in SB1 Local Partnership Program funds
- ▶ **28 blocks** on Alemany Blvd from Congdon St to Seneca Ave
 - ▶ New sidewalk construction
 - ▶ 44 new curb ramps
- ▶ Joint project with SFPUC and SFMTA; sewer replacement, 2 bulbouts, and traffic signals
- ▶ Construction to start in early 2019, open for use fall 2019



Battery and Sansome Bicycle Connections [NTIP Capital] (SFMTA) - Construction



- ▶ Prop K request: \$200,000
- ▶ Provide safe and attractive biking alternative to The Embarcadero
 - ▶ Class II bike lanes (buffered where possible)
 - ▶ Striping and signage upgrades, traffic signal adjustments, potential vehicle turn restrictions
 - ▶ No loss of parking or travel lanes
- ▶ Open for use Summer 2019
